I need an accounting from you and Borden as to why my agenda for the general meeting and in-camera meetings are being censored, weeded shorted and manipulated.

On the face of it what is happening here is totally illegal.

At this time I am addressing this as a courtesy to you and Borden.

I hope to have a complete and honest response with supporting authorities and documentation to justify your action as on the face of it both of you are well outside the scope of any legislation and bylaws. It appears that you and Borden are on a mean-spirited frolic of your own?

If I do not have an honest answer from you and Borden I will look to my other remedies including the courts if I have to. If I do not have your legal rational, justifications and authority for doing what you are doing then I will be naming you and Borden personally. If you do not provide or have Authority for what you're doing you are breaking the law. Under a recent case you are not entitled to the protection of the good-faith provisions in the Municipalities Act if you are on a frolic of your own.
